Deadline: Please have your item to the above address by **July 5, 2010**. Enclose the attached form (PDF) with your shipment and email as per instructions below.

When: July 16th to August 8, 2010 (the week before and after the Collaboration.) A reception will be held July 25th at 7:00 PM. Everyone arriving for Emma will be in town by July 25 so please try and come to the reception.

Sale of items: Gallery commission for this show is 50/50. Each artist will price their own work.

Parameters: Paint, draw (to scale), make, write about, or in any other way, interpret 'Artifact'. Have the item fit in the palm of your hand.

Definition of 'Artifact':

- Any human-made object which gives information about the culture of its creator and users.
- Any product of individuals or groups (social beings) or of their social behaviour.
- In experimental science, the expression 'artifact' is sometimes used to refer to experimental results which are not manifestations of the natural phenomena under investigation, but are due to the particular experimental arrangement.
- An object made or shaped by human hands.
- An object produced or shaped by human craft.
- Something viewed as a product of human conception or agency rather than an inherent element.
- Something characteristic of or resulting from a particular human institution, period, trend, or individual.
- Artifacts are a now-defunct hip hop duo consisting of El Da Sensei and Tame One.
- Any object made or modified by a human culture.
